**All-School Summer Reading:** Each year at Avon, we are fortunate to be able to bring an author to campus for a day to interact with our community. In preparation for that visit, we read the author's book. We are in the final stages of planning for this year's Visiting Author Program and all-school summer read. Please stay tuned for the upcoming announcement.

Summer Assignments for Advanced Placement/Honors Courses: Students enrolled in most Advanced Placement and Honors courses are required to complete additional reading and writing assignments over the summer as part of their graded coursework. Details about these assignments will be provided via Google Classroom. Students will receive login information for specific Google Classrooms via their Avon Old Farms email addresses. Since there is action required by students enrolled in these courses, please promptly access the emailed information.

World Languages Diagnostic Assessment: Students who are initially scheduled in a level two or higher course of Spanish, Mandarin or Latin are required to take a language placement test that will assist in confirming the proper course placement. The World Language Placement Tests are administered via Google Classroom. Please have your son access the language placement test using the invitation which will be sent to his issued Avon Old Farms email address in the near future. Students should complete the appropriate placement test by July 1, 2023.

Math Placement Diagnostic Assessment: Students will be asked to complete a math diagnostic assessment to assist in confirming the proper course placement. This assessment is designed to evaluate students with a wide range of math experience. Students should only complete the problems they recognize. The assessment does not permit any assistance or use of any resources other than a calculator while completing the required work. The AOF Math Diagnostic Assessment is administered via an online platform called Formative. Please have your son access the math assessment using the invitation sent to his Avon Old Farms email address. Students should complete the appropriate placement test by July 1, 2023.

College Counseling: As you approach the fall, please be aware that all sophomores and juniors will take the PSAT in October, and that we recommend that all juniors take both the SAT and ACT on the December test dates. Juniors should consider setting up their College Board and ACT accounts now since that initial set up can take a little time. Then subsequent test registration is quite easy. Juniors will be assigned college counselors in December; Sophomores will be assigned college counselors in May. Please make sure you have set up and are checking your new AOF email account regularly!

Online Bookstore: In order to make purchasing books more convenient, the school has partnered with eCampus. Families are not required to use this vendor, however. The online bookstore will be live with current information for 2023-2024 on August 7, 2023. and there will be a two-week period of free shipping following the opening of the bookstore. Families who need to travel a significant distance to school may have books mailed directly to campus at 500 Old Farms Road, Avon, CT 06001. Math Supplies: The Mathematics Department requires each student enrolled in Algebra 1 and Geometry to have a standard (non-graphing) scientific calculator. Students enrolled in Algebra 2 or above will be required to have both a scientific (non graphing) and a graphing calculator (Texas Instruments TI-84 or equivalent). Students ARE NOT ALLOWED TO use any version of the TI – Nspire (or comparable programmable) calculator.
